## **CHANGE NO. 1 OF THE CONTENT RULES OF THE COMPETITION**

<u>In connection with the questions, the Organizer changes the provisions of the Competition Regulations.</u>

# 1, Chapter IV sec.1 point d) NEW points 1) and 2) and 3) has been introduced insteed of the FORMER point no. 1):

1) one person that will participate in working on the Competition concept and Design Documentation, who holds a professional licence of an architect, without restrictions, and has expertise in carrying out, within the previous 10 years prior to the deadline for submitting Applications for qualification in the Competition, (as an author or member of a team of authors) at least one multi-trade design documentation (covering a detailed design, secondary designs and bill of quantities), on the basis of which a valid building permit was obtained for the construction of a public utility building in the meaning of Article 3(6) of the Regulation of the Minister of Infrastructure of 15 April 2022 on technical conditions of buildings and their location (i.e. Dz.U. [Journal of Laws] of 2022, item 1225, as amended), with the total floor area of no less than 20,000 m² and which includes at least a two-storey, multi-spot underground garage, a conference part with a room for no fewer than 100 persons.

### and

2) one person that will participate in working on the Competition concept and Design Documentation, who holds a professional licence of an architect, without restrictions, and has expertise in carrying out, within the previous 10 years prior to the deadline for submitting Applications for qualification in the Competition, (as an author or member of a team of authors) at least one multi-trade design documentation (covering a detailed design, secondary designs and bill of quantities), on the basis of which a valid building permit was obtained for the construction of a public utility building in the meaning of Article 3(6) of the Regulation of the Minister of Infrastructure of 15 April 2022 on technical conditions of buildings and their location (i.e. Dz.U. [Journal of Laws] of 2022, item 1225, as amended), with the total floor area of no less than 20,000 m² and which includes at least, an exhibition (museum) part with the net floor area of no less than 600 m².

#### and

3) one person that will participate in working on the Competition concept and Design Documentation, who holds a professional licence of an architect, without restrictions, and has expertise in carrying out, within the previous 10 years prior to the deadline for submitting Applications for qualification in the Competition, (as an author or member of a team of authors) at least one multi-trade design documentation (covering a detailed design, secondary designs and bill of quantities), on the basis of which a valid building permit was obtained for the construction of a public utility building in the meaning of Article 3(6) of the Regulation of the Minister of Infrastructure of 15 April 2022 on technical conditions of buildings and their location (i.e. Dz.U. [Journal of Laws] of 2022, item 1225, as amended), with the total floor area of no less than 20,000 m² and which includes at least, a concert or multi-function hall offering the possibility of organising chamber concerts for no fewer than 250 persons (excluding cinemas, stadiums and sport halls).

In connection with the above change in the content of the Reguations, man appropriate change was made in Appendix No. 3C to the Regulations (Polish version). The Appendix No. 3D to the Regulations has been canceled. The amended Competition Regulations, Polish version, (CHANGE 1 and 2) has been posted on competition website the "Competition Regulations" tab. Polish version of the Competition Rules is the only one obligatory version of the Competition Rules.
